U.S. COAST GUARD Approved Captain's Licensing Courses OUPV/6-Pack Licensing Course:

Thinking of becoming a charter boat captain? Or want to take people out on diving or fishing charters? Then you need to become a licensed captain. This course prepares you for the US Coast Guard captain's licensing exam for an un-inspected vessel and carrying up to 6 passengers (a.k.a. OUPV or "6-pack") and offers the exam on the last class day. Study areas include: general seamanship, rules of the road, chart navigation, code of federal regulations, and more. Our goal is to have you prepared to submit your licensing application with the Coast Guard when you leave our class.

Towing Endorsement Course:

This course is for those who already hold an OUPV or Master license and would like to add a Towing Endorsement. This endorsement is required to provide any commercial towing assistance to other vessels that may be aground or disabled, etc. There are no additional fees and after completing the in-class exam, you will leave the course with your diploma in hand.

Once issued a certificate of passing a licensing exam, it is good for one year from the class date. You may submit your licensing application to the US Coast Guard at any point within the year. You may NOT work as a captain for hire until you receive your actual license issued by the US Coast Guard.

Requirements for OUPV to 100 ton Master License

- _____ You must be at least 18 years old for an OUPV License
- _____ You must be at least 19 years old for a Master License
- _____ **ORIGINAL** - Proof of citizenship [i.e. Passport or birth certificate]
- _____ *Application package (CG-719B) - 3 pages (+ instructions)
- _____ *Physical & eye exam form (CG-719K) [Must be within last 12 months] - 5 pages (+ instructions)
- _____ *Drug Screening form (CG-719P) [Must be within last 6 months] - 2 pages
- _____ *Sea Service forms (CG-719S) - 2 pages
- _____ 360 total days underway on any water for OUPV; Master NC = 720 days
- _____ At least 90 days underway in the last 3 years
- _____ **ORIGINAL** -First Aid and CPR cards [Issued within last 12 months]
- _____ TWIC (Transportation Workers Identification Credential)

The USCG forms* do **NOT** need to be completed before class, but please **REVIEW** all the US Coast Guard application forms and requirements before attending the course. We will assist you in completing the forms in class. Forms are available at:

Definitions and Other Information

- **OUPV** stands for Operator of **Uninspected** Passenger Vessel, a.k.a. **6-Pack**
- With an OUPV/6-Pack license you may operate a vessel of up to 100 tons, and 65 ft. in length, but with **NOT MORE** than 6 paying passengers. Requires a minimum of **360 days** underway, with at least 90 days in the past three years.
- The OUPV/6-Pack license requires 56 hours in class.
- **Master License** means you may operate any size vessel that does not exceed the tonnage on your license. Licenses are issued in 25 - 50 - 100 ton increments and include the OUPV. A Master License is required if you operate an inspected vessel. Inspected vessels are those that carry more than six passengers. Additionally, they are built in accordance with USCG Commercial Vessel Inspection standards.
- The Master Inland License requires a minimum of **360 days** underway, with at least 90 days in the past three years. The Master Near Coastal requires a minimum of **720 days** underway, with at least 360 days in offshore waters. The Master License requires 24 hours in class.
- An **Assistance Towing Endorsement** may be added to an OUPV license, and authorizes the holder to engage in assistance towing of disabled vessels.
- When calculating sea time, a day is defined as **any 24 hour period** that you are **underway**, for more than **4 hours**. Except in special cases, you can only have 1 day logged in a 24 hour time frame.
- **All licenses** are good for 5 years, then must be renewed.
- ABM's Captain School courses are limited to **12 students** and must be reserved in advance by submitting 50% of the tuition due.
- A one-time \$50 paperwork processing fee will be added to each student's bill. This fee can be paid on the first day of class.
